Nishimoto presiding, previously entered the following orders in this action: (1) Order dated May 27, 2004 granting Defendant DIRECTV, Inc.'s Special Motion to Strike Plaintiff's Complaint Pursuant to Cal. IT IS FURTHER ORDERED, ADJUDGED AND DECREED that defendant DIRECTV, Inc. shall recover from plaintiff John Fisher the sum of \$14,600.00 in attorney's fees, pursuant to Cal. Civ. Proc. Code § 425.16(c).


The Clerk is ordered to enter the judgment.
