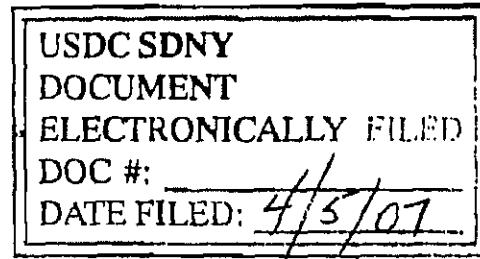





Plaintiff, DIRECTV, INC., by their attorneys LONSTEIN LAW OFFICE, P.C., Julie Cohen Lonstein, of counsel and Defendants, by their attorney, LAW OFFICES OF JOEL ZWEIG, Joel Zweig, of counsel, hereby agree to the entry of judgment in favor of Plaintiff and against Defendants, jointly and severally for the sum of FIFTY THOUSAND (\$50,000.00) DOLLARS for Defendant's unauthorized showing of the 2006 NFL SUNDAY TICKET within the commercial location known as BOUNCE at 1403 2nd Avenue, New York, New York 10021 in violation of 47 U.S.C. §605 and 18 U.S.C. §2511.

It is hereby stipulated and agreed to by and between the parties herein that each of the Defendants be enjoined and restrained from intercepting, exhibiting, recording, re-transmitting, or disseminating in any fashion, any portion of any programming presented, marketed and promoted by DIRECTV, without prior express authorization pursuant to a commercial agreement within the location, of DIRECTV, and from broadcasting any footage of any programming marketed or promoted by DIRECTV without prior express authorization pursuant to a commercial agreement within the location, from DIRECTV, and it is further AGREED and STIPULATED that any violation of this Stipulation and Order would cause irreparable harm to Plaintiff and as such, the parties agree and consent that in that event, equitable relief is a proper remedy.


